RETENTION OF TITLE

- Title shall not pass. Title to and ownership of the goods remains with Fast Office Furniture Pty Ltd (the seller) until (the buyer) has paid for the 13.1 (goods) in full and including G.S.T., delivery charges and other duties or charges invoiced
- Relationship between (seller) and (buver) 13.2
 - The (buyer) shall take custody of the (goods) and retain them as the fiduciary agent and bailee of Fast Office Furniture Pty Ltd (the seller) Storage of the goods.
- Subject to dealing with the goods as contemplated by this clause, the (buyer) must keep the (goods) stored separately and in a manner to enable 13.3 them to be identified, properly stored, protected and insured. The (buyer) must not create any form of encumbrance over the goods which is inconsistent with Fast Office Furniture Pty Ltd (the seller) title to and ownership of the goods Authority to repossess
- If the (buyer) does not pay for the goods in full, the (buyer) authorises Fast Office Furniture Pty Ltd (the seller) and its servants and agents, to 13.4 enter upon the (buyers) premises at any time to do all things necessary to repossess the (goods). Dealing with the goods – resell

If the new product is not sold to a third party the (buyer) 13.6.2 agrees with Fast Office Furniture Pty Ltd (the seller) that ownership in the new goods immediately passes to Fast Office Furniture Pty Ltd (the seller) and subclauses 13.3 and 13.4 apply to the new product.
- Outstanding balances on overdue accounts shall be charged interest at the rate of 5% p.a. calculated daily from the date on which the account 14 becomes overdue
- These conditions (which shall only be waived in writing signed by the Seller) shall prevail over all conditions of the Buyer's Order to the extent of 15
